As an active member or retiree of AFSCME COUNCIL 4, you have a no-cost **\$4,000 Accidental Death & Dismemberment** benefit. You can also receive Child Safe Kits for your children and grandchildren at no cost. These kits help you gather vital data, photos and fingerprints for authorities in the event of an emergency.
